

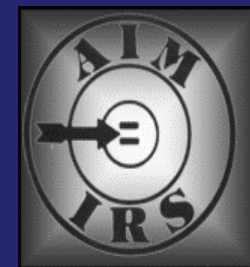
OUR MISSION
